Consequent to the aforesaid allotment, the paid-up equity share capital of the Company has increased from Rs.61,00,65,856/- comprising 30,50,32,928 Equity Shares of face value Rs.2/- each to Rs.61,04,19,628/- comprising 30,52,09,814 Equity Shares of face value Rs.2/- each. The Promoters of the Company, namely Mr. Sanjay Aggarwal and Mr. Sandeep Aggarwal, have purchased 1,31,000 Equity Shares and 1,26,500 Equity Shares, respectively, from the open market during the month of December 2025. Accordingly, the promoter shareholding of the Company has increased from 49.03% to 49.12% of the total paid-up equity share capital of the Company.</p>
